1. All applications must include a complete listing or merchandise of what you are selling.
2. The festival is a "rain or shine" event and will only be cancelled in the event of severe weather.
3. Vendors need to bring their own tables, chairs, and protection from the weather.
4. Details on vendor unloading and parking will be provided during the week of the event.
5. Vendor spots will be in a grass field.
6. If you have a generator, it cannot be loud or smokey, ultra quiet generators only, if you don't you will be asked to leave the event.
7. Tatamy Borough does not assume responsibility for any lost, stolen, or damaged goods or personal items.
8. Tatamy Borough requires the Application and Liability Wavier to be completed by October 1st, 2025, for acceptance.

(2) INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity, whether caused by the negligence of release or otherwise.

I acknowledge that the Borough of Tatamy,
and their directors, officers, volunteers, representatives, and agents are NOT responsible for errors, omissions, acts, or failures to act of any party or entity conducting a specific activity on their behalf.

I acknowledge that this activity may involve a test of a person's physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, lack of hydration, and actions of other people, including, but not limited to, participants, volunteers, monitors, and/or producers of the activity. These risks are not only inherent to participants but are also present for volunteers.
