ORDINANCE NO. 305-2024

(Duly Adopted 5th day of February 2024)

AN ORDINANCE OF THE BOROUGH OF TATAMY, NORTHAMPTON COUNTY, PENNSYLVANIA, AMENDING TITLE VII , CHAPTER 76 OF THE TATAMY BOROUGH, PENNSYLVANIA, CODE OF ORDINANCES, TRAFFIC CODE, PARKING SCHEDULES, SCHEDULE I, PARKING PROHIBITED.

AMENDING CERTAIN ORDINANCES OF THE BOROUGH OF TATAMY, NORTHAMPTON COUNTY, PENNSYLVANIA, ORDINANCE NO. 26-1962 AS AMENDED AND ENTITLED, "AN ORDINANCE PRESCRIBING TRAFFIC AND PARKING REGULATIONS AND PROVIDING PENALTIES FOR THEIR VIOLATION" AND ORDINANCE NO. 60-1969 AS AMENDED AND ENTITLED, "AN ORDINANCE PRESCRIBING TRAFFIC AND PARKING REGULATIONS AND PROVIDING PENALTIES FOR THEIR VIOLATIONS" AND ORDINANCE 234-2008 AS ENTITLED "AN ORDINANCE PRESCRIBING TRAFFIC AND PARKING REGULATIONS AND PROVIDING PENALTIES FOR THEIR VIOLATION" SECTION 3. "PARKING PROHIBITED AT CERTAIN LOCATIONS".

BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL FOR TATAMY BOROUGH, NORTHAMPTON COUNTY, PENNSYLVANIA, AND IT IS HEREBY ORDAINED AND ENACTED BY THE AUTHORITY OF THE SAME AS FOLLOWS:

SECTION 1. PURPOSE, FINDINGS AND DECLARATION OF POLICY.

WHEREAS, the Borough has the authority to regulate and prescribe rules and regulations for traffic and parking; and

WHEREAS, the Borough is to promote the public safety, health, and welfare by establishing certain streets in the Borough of Tatamy, as Prohibited Parking; and

WHEREFORE, the borough hereby amends Title VII of the Borough of Tatamy, Codified Ordinances, Traffic Code, Section 76, Traffic Code, Parking Schedules, amending Schedule I, Prohibited Parking.

SECTION 2. DEFINITIONS.

For the purposes of this Ordinance, the following definitions shall apply:

- "Traffic control devices" means a sign, signal, marking, or other device placed on or near a street or highway by lawful authority to regulate, warn, or guide traffic.

SECTION 3. AMENDING SCHEULE I

The following streets in Borough of Tatamy, Northampton County, are hereby establishing parking restrictions as follows:

Green Street On the north side, westerly for a distance of 237 feet, beginning at the intersection of Green Street & South Fourth Street and ending 237 feet from Fourth Street.

SECTION 4. ENFORCEMENT

The Borough Police Department is hereby authorized to enforce the provisions of this Ordinance.

SECTION 5. REPEALER.

All Ordinances and parts of Ordinances inconsistent herewith are hereby specifically repealed.

SECTION 4. SEVERABILITY.

The provisions of this Ordinance shall be severable and, if any provisions thereof shall be declared unconstitutional, illegal, or invalid, such decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as a legislative intent of the Borough of Tatamy that this Ordinance would have been enacted as otherwise set forth had such unconstitutional, illegal, or invalid provision(s) not been included herein.

SECTION 5. EFFECTIVE DATE.

This Ordinance shall take effect 30 days after passage and be in force from and after said date.
