RE: Draft Ordinance 304-2024, Creating a One-Way, South Fourth Street & Draft Ordinance

305-2024, Restricting Parking, Green Street.

Hello, Residents,

This letter is to serve as an important notice and invitation to attend the Borough of Tatamy Council meeting on Monday, 5 February 2024. The meeting is scheduled to commence at 7:00 PM. The meeting location will be at the Llantrisant Retreat and Wellness Center, 336 Bushkill Street Tatamy, PA. The Borough Council will be discussing two proposed draft ordinances, the first, creating a One-Way Road on Fourth South Street, Southward ending at Broad Street. The second, amending a previous ordinance, extending no parking on the Northern side of Green Street.

We understand that ordinances can directly impact our community and quality of life and believe in transparent communication and your voice in shaping our local regulations. This meeting presents an opportunity for affected residents that reside on these two streets, to learn more about the proposed ordinances, ask questions, and provide valuable feedback to the Borough Councilpersons.

What will be discussed:

ORDINANCE 304-2024

AN ORDINANCE OF THE BOROUGH OF TATAMY, NORTHAMPTON COUNTY, PENNSYLVANIA, AMENDING TITLE VII, CHAPTER 71 OF THE TATAMY BOROUGH, PENNSYLVANIA, CODE OF ORDINANCES, TRAFFIC CODE, TRAFFIC REGULATIONS, CREATING SECTION 71.23, ONE WAY ROADWAY.

What does this mean? The proposed ordinance will create a one-way roadway on South Fourth Street from Main Street up to Broad Street. Parking on South Fourth Street will not be affected.

AMENDING CERTAIN ORDINANCES OF THE BOROUGH OF TATAMY, NORTHAMPTON COUNTY, PENNSYLVANIA, ORDINANCE NO. 26-1962 AS AMENDED AND ENTITLED, "AN ORDINANCE PRESCRIBING TRAFFIC AND PARKING REGULATIONS AND PROVIDING PENALTIES FOR THEIR VIOLATION" AND ORDINANCE NO. 60-1969 AS AMENDED AND

ENTITLED, "AN ORDINANCE PRESCRIBING TRAFFIC AND PARKING REGULATIONS AND PROVIDING PENALTIES FOR THEIR VIOLATIONS" AND ORDINANCE 234-2008 AS ENTITLED "AN ORDINANCE PRESCRIBING TRAFFIC AND PARKING REGULATIONS AND PROVIDING PENALTIES FOR THEIR VIOLATION"

SECTION 3. "PARKING PROHIBITED AT CERTAIN LOCATIONS".

What does this mean? Currently, on the northern side of Green Street, in front of a portion of the public works garage, there is a no parking restriction for a distance of 30 feet. The proposed ordinance will increase this distance to 237 feet, beginning at South Fourth Street and ending 237' in a westerly direction, ending approximately at the end of the public works building.
